# The Three Pillars of United Way

Traditionally, the United Way has three fundamental operational goals (or pillars) that every United Way works to improve in their service area. These three pillars are health, education, and financial stability. Each agency partner to whom Kewanee Area United Way awards financial support, will in some way address one or more of these pillars.

# 2024 Highlights

## **BUILDING FOR THE FUTURE**

- 15 (501(c)3) Partner Agencies were funded in 2024. Grants in the amount of \$93,500 were distributed to those agencies monthly, providing financial resources essential to Henry and Stark County residents.
  - These agencies provide; food; shelter; counseling; crisis intervention; housing, domestic abuse intervention, support and treatment; Emergency supplies; tutoring and after school programs in the schools; assistance and programming for the disabled; assistance to the elderly to remain at home; youth development; home delivered meals; distribution of food to those needing assistance; provision of free home repairs and ramps to qualified homeowners; help to the homeless; and summer reading programs.
- As a result of the tornadoes that struck the Kewanee area on July 15 2024, a \$2000 Disaster Assistance Grant was distributed to the Kewanee Salvation Army 360 Center to help address needs created for local residents.
- SHOES FOR KIDS was launched in March 2024 to help children enter school ready to learn. Studies have shown that providing appropriate school attire builds self-esteem and a willingness to learn in young children. This year shoes were provided to children PreK through 6<sup>th</sup> grade in the Kewanee and Wethersfield school systems. 250 pairs of shoes were distributed to children that otherwise may have started the school year with shoes that did not fit, were inappropriate for school, worn out or in general just did not work the child. Provision of appropriate footwear started these kids off in the new school year with excitement and self-worth. Volunteers were moved by the children's responses; from joyful smiles, thank yous, tears and hugs!
- IHMVCU collected books for grade school children in the fall and KAUW had the honor of delivering the books to area schools.
- Throughout the year, KAUW has relied on local businesses and area residents to support the outreach to this area. We are honored to have a growing relationship with this area to support growth and development in the focus of Kewanee Area United Way.

## **Independent Auditor Review**
